Highlights from Voters' Meetings and Activities in 2021

Four regular Voters' Meetings were held on January 24th, April 25th, July 25th, and October 31st. The Annual Budget/Election Meeting was held November 22nd.

January 24th – The Voters' Meeting was held with 26 members and 0 visitors attending. 1) COVID restrictions and changes were discussed. 2) Update on funding for exterior rock repairs \$28,000 raised of \$40,000 goal.

April 25th - The Voters' Meeting was held with 27 members and 1 visitor attending. 1) Attendance is up as COVID restrictions have been removed. 2) Upcoming 150th anniversary celebration and installation of Christian Schultz. 3) Prayers for Trinity McFarland as Pastor Vossler holds a call to Sanford, Michigan. 4) Membership additions – Mackenzie Howey, Wendy Miller (Tatum & Bristol, Dustin Sievers (Hannah, Alannah, Noah). 5) Motion to proceed with organ cleaning and repairs at a cost of \$21K.

July 25th - The Voters' Meeting was held with 30 members and 0 visitors attending. 1) Things returning to "normal" as most COVID restriction were lifted last quarter. 2) Discussed new Giving Plus program for online and auto giving. 3) Rock repair bids came in below estimates (\$15,600). 4) Success and follow up of VBS and possible future family activities. 5) Membership additions – Lindsey Wertzberger, Corey & Christa Kraus, Taylor & Courtney Giefer (Chet). 6) Insurance change adopted – less expensive for congregation and employees.

October 31st - The Voters' Meeting was held with 26 members and 0 visitors attending. 1) Elders discontinuing tuition discount for church attendance. 2) Finances discussed – borrowed \$50k this year (internal) with \$5k repaid at this point. 3) Projects ongoing – exterior rock, organ and asphalt repairs. 4) Suicide Awareness a positive event with 60+ in attendance. 5) Budget presented and discussion on possible short fall.

November 22nd - The Voters' Budget/Election Meeting was held with 27 members and 0 visitors attending. 1) Proposed budget was approved. 2) Newly elected officers are: Ervan Steuwe, President; Don Frank, Elder; Kip Meseke, Elder; Cheryl Buttenhoff, Board of Christian Education; Rita Zeller, Board of Education; Dale Peterson, Trustees; Christa Kraus, School Board; Ryan Theel, Stewardship – Financial Secretary.
